Sutton Fields II Public Improvement District Neighborhood Improvement Area #4 – Lot Type B – 60 Ft Lot Phase #4B of Development

Project Overview

The Sutton Fields II Public Improvement District (the "District") was created by the City Council of the City of Celina on October 13, 2015, pursuant to the Public Improvement District Act, Texas Local Government Code, Chapter 372, as amended (the "Act"), and Resolution No. 2015-51R upon petition of the owners of the taxable real property representing more than 50 percent of the appraised value of taxable real property liable for assessment within the District and the property owners who own taxable real property that constitutes more than 50 percent of the area of all taxable real property that is liable for assessment by the District.

The District was created principally to finance certain public improvement projects for the residential development located within the boundaries of the City of Celina (the "City") and within the extraterritorial jurisdiction of the City. An Amended and Restated Service and Assessment Plan was accepted and approved by the City Council which set forth the plan for apportioning the costs of certain of the public improvement projects (the "Authorized Improvements") to be assessed against properties in the Neighborhood Improvement Area #4 ("NIA #4") of the District and for payment of Special Assessments with respect thereto on July 14, 2020.

The City issued the City of Celina (Sutton Fields II Public Improvement District Neighborhood Improvement Areas #4 Project) Special Assessment Revenue Bonds, Series 2020 (the "NIA #4 Bonds") in the aggregate amount of \$4,000,000 pursuant to the Act, an Ordinance adopted by the City Council on September 8, 2020 and an Indenture of Trust dated as of September 1, 2020 between the City, and the U.S. Bank, N.A. as trustee.

The NIA #4 Bonds are payable from Special Assessments levied against each parcel of property within NIA #4 of the District pursuant to the Assessment Ordinance adopted by the City Council. The Act provides that the Special Assessments (including any reassessment, the expense of collection and reasonable attorney's fees, if incurred) are (a) a first and prior lien against the property assessed, superior to all other liens and claims except liens or claims for state, county, school district or municipality ad valorem property taxes whether now or hereafter payable, and (b) a personal liability of and charge against the owners of the property to the extent of their ownership regardless of whether the owners are named.

^{2 -} The principal and interest amounts are based upon the pro rata share of NIA #4 Bonds and will not increase during the life of the Bonds. Interest amounts are calculated through the principal payment date of each year.

^{3 -} The principal and interest amounts are based upon the pro rata share of the NIA #2-5 Bonds and will not increase during the life of the bonds. Interest amounts are calculated through the principal payment date of each year.

^{4 -} The Administrative Expenses shown are estimates and will be updated each in the Annual Service Plan Update.

^{5 -} The total annual installment does not include TIRZ credit, if any.

Example of TIRZ Credit Application

The property in the PID is also located in the City of Celina Tax Increment Reinvestment Zone No. 8. The City has committed to use approximately 7.76% of the annual incremental City ad valorem property taxes collected from a property in the <u>current</u> tax year as a credit (the "TIRZ Credit") to reduce the PID annual installment of assessments due in the <u>following</u> year. The following hypothetical example illustrates the application of the TIRZ Credit:

A) Estimates for illustration purposes:

Estimated prorated base year (2017) taxable value = \$1,000

Estimated current year (2022) taxable value = \$328,000

Estimated current (2022) incremental value = \$327,000 (i.e. \$328,000 - \$1,000)

Estimated current (2022) City tax rate per \$100 of taxable value = \$0.645

Estimated PID current (2022) annual installment of Assessment = \$1,759

Estimated PID next (2023) annual installment of Assessments = \$1,735

B) Estimated City incremental tax:

$$2,109$$
 [i.e., $327,000 \div 100 \times 0.645 = 2,109$]

C) Estimated TIRZ Credit:

$$164$$
 (i.e., $2,109 \times 7.76\% = 164$)

D) PID current annual installment due (2022):

\$1,759 with no prior year TIRZ Credit

E) Estimated PID next annual installment due (2023):

$$1,571$$
 (i.e., $1,735 - 164 = 1,571$) after application of the 164 TIRZ Credit
