

**Waxahachie Public Improvement District  
Phase #2 – Lot Type 1 – 90 Ft.**

**Project Overview**

The Waxahachie Public Improvement District No. 1 (the “District”) was created by the City of Waxahachie City Council on April 16, 2007, pursuant to the Public Improvement District Assessment Act, Texas Local Government Code, Chapter 372, as amended (the “Act”), and Resolution No. 1087 upon petition of the owners of the taxable real property representing more than 50 percent of the appraised value of taxable real property liable for assessment within the District and the property owners who own taxable real property that constitutes more than 50 percent of the area of all taxable real property that is liable for assessment by the District.

The District was created principally to finance certain public improvements (the “Authorized Improvements”) that specially benefit assessed property in the District. All of the property in the District was located within the corporate limits of the City of Waxahachie (the “City”) at the time of District creation. On June 7, 2021, the City Council adopted Ordinance No. 3277 that approved a Service and Assessment Plan updated for Phase #2 of the District (the "Updated Service and Assessment Plan") and levied Special Assessments (the "Phase #2 Assessments") on certain property within Phase #2 in accordance with the proposed Phase #2 Assessment Roll attached as Appendix C-2 to the Updated Service and Assessment Plan. The Phase #2 Assessments may be prepaid in whole or in part at any time or may be paid in Annual Installments as provided by the Act and the Service and Assessment Plan.

The City executed a reimbursement agreement for the Waxahachie Public Improvement District No. 1 – Phase #2 District Improvements in the aggregate amount of \$749,059 pursuant to the Act.

All Phase #2 Assessments that are not paid in full will be billed in Annual Installments and collected each year by the City, or its designee, as provided in the Service and Assessment Plan. Annual Installments are due and payable as provided on the Annual Installment assessment bill. Annual installments are expected to be billed and collected on the same schedule as property taxes. The Phase #2 Assessments, including the annual installments thereof, are (a) a first and prior lien against the property assessed, superior to all other liens and claims except liens or claims for state, county, school district or other political subdivision ad valorem property taxes, whether now or hereafter payable, and (b) a personal liability of and charge against the owners of the property to the extent of their ownership regardless of whether the owners are named.

The exact amount of each annual installment will be approved each year by the City Council in the Annual Service Plan Update for the District.
