## The Parks at Panchasarp Farms Public Improvement District Lots Triggered for Collection in 2022-23 Phase #2 – Lot Type 4 – 55 Ft Project Overview

The Parks at Panchasarp Farms Public Improvement District (the "District") was created by the City Council of the City of Burleson (the "City") on February 4, 2019, pursuant to the Public Improvement District Act, Texas Local Government Code, Chapter 372, as amended (the "Act"), and Resolution CSO#981-02-2019 upon petition of the owners of the taxable real property representing more than 50 percent of the appraised value of taxable real property liable for assessment within the District and the property owners who own taxable real property that constitutes more than 50 percent of the area of all taxable real property that is liable for Assessment by the District.

The District was created principally to finance certain public improvement projects for the residential development located within the boundaries of the City of Burleson. A Service and Assessment Plan updated for Phase #2 was accepted and approved by the City Council on March 21, 2022, pursuant to Ordinance CSO#2008-03-2022 (the "Assessment Ordinance"), setting forth the plan for apportioning the costs of certain of the public improvement projects (the "Authorized Improvements") to be assessed against properties in the District and for payment of Special Assessments with respect thereto.

All Assessments that are not paid in full will be billed in annual installments and collected each year by the City, or its designee, as provided in the Service and Assessment Plan. <u>Annual</u> <u>Installments are billed by the Johnson County Tax Office and are due and payable as</u> <u>provided on the annual installment assessment bill.</u> Annual installments are expected to be billed and collected on the same schedule as property taxes. The Assessments, including the annual installments thereof, are (a) a first and prior lien against the property assessed, superior to all other liens and claims except liens or claims for state, county, school district or other political subdivision ad valorem property taxes, whether now or hereafter payable, and (b) a personal liability of and charge against the owners of the property to the extent of their ownership regardless of whether the owners are named.

Effective January 1, 2024, for any singlefamily residential parcel prepaying an Assessment, a \$500 fee will be included in the total payoff amount to cover processing and other lien release related filing expenses.
